**Check-In:** Please arrive for vendor set-up between 9:00am-10:00am and be ready to go by 10:45. Please check in at the Chamber's booth for designated exhibit space, drop off supplies and park your vehicle on surrounding Street parking. Please allow adequate time to park.

**Exhibit Space Fee: \$400 (Chamber members \$350)** Includes a 10x10 exhibit space with tent canopy, 8' table, red Linen and 2 chairs. If you own your own canopy and wish to bring it, please notify us in advance. You may set-up your display with any promotional signs, banners, and decorations you wish. Canopies larger than 10x10 must purchase additional space. All vendor product, merchandise, signs and sales personnel must conduct business within their exhibit areas. Electricity not provided. Please notify in advance if you plan to bring a silent generator.

**Vendor Event Schedule:** Vendors must be ready to go by 10:45am and remain in designated vendor space until 4:00pm. All vendors and vendor equipment must be removed from the lot no later than 5:00pm
